We were dealing with Owen Turner at the time. We also asked you to investigate my corrupt Lawyer on the 17/7/2015 (Ref: 2015-777) so we have had communication in the past.

We presented in person the over view of the Petition to the 9 Members of the Primary Production Select Committee. You will see in the over view and hear on the audio tape that the committee were well aware of the treasonous acts towards our veterans, they even joked about it. (Refer to audio tape) Treason had been raised on three occasions in Parliament. The only conclusion we arrived at, is that the Members of Parliament (past and present) have a personal interest on Soldiers Holdings today. This would explain why the Ministry of Justice, chose to write and publish their own personal opinion of events, which were false. The Ministry of Justice has no credibility so how can they address the Maori Miliatry Veterans claim using the same expert that wrote this report, Professor Ashley Goulds' credibility is now in question. This is when specialised units like Serious Fraud come into power.

This to explains why the Solicitor General has suppressed the evidence of proof for this claim. The timber alone on my grandparents estate runs into the billions.
