RE: YOUR LETTER TO CHIEF JUDGE ISAAC CONCERNING JANET MASON

Thank you for your information concerning Janet Mason and Wai 2500, the Military Veterans Inquiry, received on 15 October 2015. I apologise for the delay in responding to you.

The Tribunal has placed a copy of the information on the Tribunal's records for future reference.

The Waitangi Tribunal's functions are to inquire into allegations by Maori about Crown actions and omissions that may have breached of the principles of the Treaty of Waitangi. The Crown is considered the executive branch of government, not individuals. Unfortunately this means the Waitangi Tribunal cannot look into a lawyer's actions in representing their clients, in particular Ms Mason's actions representing your claim.

Alternatively, you could contact the Law Society for advice on the allegations in the information you provided to the Tribunal. The Law Society is responsible for regulating lawyers who practise law in New Zealand. It operates the Lawyers Complaints Service. The Service handles all complaints about lawyers or former lawyers. We could not understand why Janet never questioned the decision made by the Legal Aid specialist Adviser. So we challeged the Justice department ourselves, when Janet should have been doing her job as my lawyer in repersenting my claim for my best interest, and had been paid to do so.

Janet then left the appeal up to me, then not long after that she dropped me like a ton of bricks and retained a large amount of our historic documents and research.

There is no questions, when it comes to dealings with the Treaty, as Legal Aid is very obiliging to accommodate.

If Janet has done this to me, what is she capable of doing to you.

I do apologise for the inconvenience thats been put upon you. If Janet Mason did her job, that she had been paid to do, our claim would have been through the Courts years ago.

Im confused, how can a lawyer take evidence from one court case then submit it into another under a different name.

This would have made your Wai 2500 easier, as the Limitation Act would not apply.

These are acts of Treason, the only place we believe to gain justice, is in the International Court of Justice, which Janet thought it to be a brilliant idea.

Another con from Janet, leading me on for our information and our historic documentation.
